# 1. Update on Gibson Street Lift Station Project.

Nick Bellar reported for Jeremy Lin; who was absent from the meeting, he updated the board on the Gibson Street Lift Station Project. All the wet well infrastructure for the lift station is installed. Force Main on Gibson has been installed, and they are working on the lift station now. We're currently looking at June 1 start up. They are going to be starting work on the gravity sewer shortly that is on 117<sup>th</sup> Avenue.

### 2. Update on 117th Ave. Lift Station, Lennar.

Nick Bellar updated the Sewer Board on the 117<sup>th</sup> Avenue Lift Station Project. It's operational and has been working well. There are still some punch-list type items to be completed. When the weather warms up, they will be able to finish up completely. Tim Clayton asked that this be removed from the agenda now that it is operational.

1. Recommendation to Town Council, Change Order #3, Gibson St. Lift Station, Integral Construction, \$76,078.00, for Relocation of Gravity Sewer.

This is the Gibson Street Lift Station Project. It is a sewer project. However, we're using town funds from the TAFT Infrastructure Funds. This will be an approval and recommendation to the Town Council to pay. The first one on the agenda is a change order in the amount of \$76,078.00. This was to relocate the 15-inch gravity sewer to the south side of the road. Mark Wacnick made a motion to Approve the Recommendation to Town Council, Change Order #3, Gibson St. Lift Station, Integral Construction, \$76,078.00, for Relocation of Gravity Sewer. Tim Clayton seconded the motion. All in favor. The motion carried 2-0.

- Recommendation to Town Council, Change Order #5, Gibson St. Lift Station, Integral Construction, \$3,382.00, Design Change in Manhole Cleanouts.
   Mark Wacnick made a motion to Approve Recommendation to Town Council, Change Order #5, Gibson St. Lift Station, Integral Construction, \$3,382.00, Design Change in Manhole Cleanouts. Tim Clayton seconded the motion. All in favor. The motion carried 2-0.
- 4. Recommendation to Town Council, Pay Request #5, Gibson St. Lift Station, Integral Construction, \$248,719.00.
