### **NEW BUSINESS:**

- 1. Report on Wastewater Treatment Plant Expansion Bids Received December 5th, 2023 and Update on Financing of Project. Per Jeremy Lin the town received two bids. Hasse Construction was the lowest bidder. He can recommend the bid to Hasse Construction in the amount of \$10,156,000 Rick stated they are finalizing financing, \$8.6 million from Building Corp, \$973,926 ARPA funds on hand and \$818,624 of system development charges. Total expenses are just over \$10.3 million including cost of issuance. Zack Beaver made motion to reward the bid to Hasse Construction Company for the Wastewater Treatment Plant Expansion in the amount of \$10,156,000.00 pending closing on financing. Jon Derwinski seconded the motion. The motion carried 4 to 0.
- 2. Consideration of Construction Engineering Services for Public Works Building Project with Lintech Engineering. Nick Bellar stated this is for the construction engineering services for the Public Works Building Project. This proposal is for Jeremy Lin to execute various construction services in the amount of \$35,000.00. Dave Anderson made a motion to approve Construction Engineering Services for Public Works Building Project with Lintech Engineering in the amount of \$35,000.00. Zack Beaver seconded the motion. The motion carried 4 0.
- 3. Consideration of Change Order #5, Rieth-Riley Construction, Decatur St. Paving Project, a deduct of (\$4,600.00).
